**NOTIFICATION**

**Dated Kohima, the 15<sup>th</sup> of December, 2008**

**NO. PAR – B / 5 / 2008** : : In exercise of the powers conferred by the proviso to Article 320 (3) of the Constitution of India, the Governor of Nagaland is pleased to make the following rules further to amend the Nagaland Public Service Commission (State Civil & Other Services), Recruitment Rules, 2008, namely: -

1. (1) These rules may be called the *Nagaland Public Service Commission (State Civil & Other Services) Recruitment (3<sup>rd</sup> Amendment) Rules, 2008.*

(2) They shall come into force with immediate effect.

2. **Amendment of Rule 8**

The entries under Rule 8 (iii) of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, viz:

**Rule 8 (iii) :**

Recruitment through written competitive examination without interview will be conducted for recruitment of LDA-cum-Computer Assistants for the Nagaland Civil Secretariat.

3. **Amendment of Rule 11**

The entries under Rule 11 of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, viz:

**Rule 11 :**

All applications will be submitted in the prescribed form, which may be downloaded from the web site or obtained from the Office of the Commission on payment of the prescribed fee. Prescribed application form for the Technical Services is given in Annexure-III A, for NCS & Allied Services/non-Technical Services in Annexure-III B and Annexure-III C for LDA-cum-Computer Assistants in the Nagaland Civil Secretariat.

4. **Amendment of Rule 13**

The entries under Rule 13 (c) of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, viz:

**Rule 13 (c) :**

Written examination only for recruitment of LDA-cum-Computer Assistants in the Nagaland Civil Secretariat.

5. **Amendment of Rule 16**

The entries under Rule 16 (1) and 16 (13) of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, **while entries under Rule 16 (14) shall stand deleted.**

**Rule 16 (1) :**

There will be a common written examination for direct recruitment of Lower Division-cum-Computer Assistants for the NPSC, Vigilance Commission and CEO's offices.

**Contd.**

Rule 16 (13) :

The candidates figuring in the merit list will be considered for appointment against the vacant posts in the NPSC, Vigilance and CEO's offices in order of merit and preference.

6. Amendment of Annexure-III C

Annexure-III C of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be amended in the following manner, viz:

1. The entries under Column 5 shall be substituted by the following entries, viz: "NAMES OF THE OFFICES APPLIED FOR IN ORDER OF PREFERENCE (eg NPSC, Vigilance Commission and CEO's offices)."
