NO. PAR – B / 5 / 2008 : : In exercise of the powers conferred by the proviso to Article 320 (3) of the Constitution of India, the Governor of Nagaland is pleased to make the following rules further to amend the Nagaland Public Service Commission (State Civil & Other Services), Recruitment Rules, 2008, namely: -

1. (1) These rules may be called the *Nagaland Public Service Commission (State Civil & Other Services) Recruitment (4th Amendment) Rules, 2009.*

(2) They shall come into force with immediate effect.

2. **Amendment of Rule 14 (1) (b)**

The entries under Rule 14 (1) (b) of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, viz:

Rule 14 (1)(b) :

The Question Paper will be Multiple Choice Questions (MCQ) with negative marking of half mark for every wrong answer. The number of questions will be 200 with 1 mark for each question. The question paper and the answer sheet shall be given separately. The model answer sheet shall be published soon after completion of the Preliminary Examination to enable the candidates to file complaints, if any.

Provided that a Committee shall be constituted, comprising of the following officials, to examine and dispose all such complaints, if any, and whose decision shall be final in all respects-


