NO. PAR – B / 5 / 2007 NPSC(Pt-I) : : In exercise of the powers conferred by the proviso to Article 320 (3) of the Constitution of India, the Governor of Nagaland is pleased to make the following rules further to amend the Nagaland Public Service Commission (State Civil & Other Services), Recruitment Rules, 2008, namely: -

1. (1) These rules may be called the *Nagaland Public Service Commission (State Civil & Other Services) Recruitment (5th Amendment) Rules, 2010.*
(2) They shall come into force with immediate effect.

2. **Amendment of Rule 15 (1) (b)**

The entries under Rule 15 (1) (b) of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, viz:

Rule 15 (1)(b) : The assignment of marks and time will be as follows:

<u>Paper</u>	<u>Maximum marks</u>	<u>Duration</u>
i) General English and General Knowledge (Combined)	100	3 Hours
ii) Technical Subject - Paper I	200	3 Hours
iii) Technical Subject - Paper II	<u>200</u>	<u>3 Hours</u>
Total	<u>500</u>	<u>9 Hours</u>

3. **Amendment of Rule 15 (2)**

The entries under Rule 15 (2) of the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008, shall be substituted by the following entries, viz:

For the Technical Subject paper, the pattern of question will be MCQ type: There will be 200 questions on each paper, with 1 (one) mark for each question, with negative marking of ½ mark for each wrong answer.
